In a recent visit to Malaysia, the K.B. Foundation was advised of the work being undertaken by the Dominica Natural Disaster and Development Fund in the UK and in particular the request for assistance made by the Office of Disaster Management in Dominica, in the area of assistance for disaster preparedness, which is under consideration by the Fund.
